Claim applications will be issued to the depositor/authorized representative/nominee and in the absence of the nominee, the Power of Attorney (PoA) holder, who will approach the office with a clear identity card with photograph/proof of investment documents or original copies of Bonds, Proof of Investments, official letter /Power Of Attorney (PoA) documents.

- Opening date for Submission of Claim Applications is **20/07/2023**. Last date for submission of claim application will be **19/08/2023** before **5.30 PM**. The Claim applications will be received only during office hours between 10:30 A.M and 5:30 P.M.(Date:20.07.2023 to 19.08.2023)
- Any application received after the last date fixed for submission of claims under Section 7(2) and 7(3) of the KPIDFE Act will not be accepted under the provisions of the KPIDFE Act,2004.
- If false/concocted applications are submitted without legally valid proof of investment, such applications will be rejected summarily and Civil and Criminal cases will be registered against such applicants as per law.
- As per Section 7(2) of KPIDFE Act, 2004 the time limit for submission of claim applications is from Date: **20/07/2023** to **19/08/2023** between **10.30 A.M.** and **05.30 P.M.**
- There will be no facility/provision to submit the claim applications through online.
