## Terms & Conditions:

- 1) Should not be older than 65 years.
- 2) Should have requisite qualification as prescribed for specialization under the Wealth Tax Act.
- 3) Should be located in the Head Quarter of the regions i.e., Delhi, West Bengal, Andra Pradesh, Kerala & Uttar Pradesh.
- 4) Experience in concerned specialization for at least 5 years (at least 2 years for Central/State government or public sector Banks).
- 5) Affiliated to IBBI for at least 2 years. No record of suspension, no criminal cases.
- 6) Documents (to be scanned and uploaded to e-mail)
  - 1) Educational qualification (Highest).
  - 2) SSLC Marks card for Age proof.
  - 3) Experience with Central/State Government/Public sector Bank work order / Satisfactory performance certificate.
  - 4) Affidavit for not having any criminal case. Accepting Conditions of Valuation SOP and having no interest in land/real estate, scrap dealing/auctioning or having no relation formal/informal with any financial establishment or its office bearers who are charged with any fraud or violation.
  - 5) PAN, Aadhar and personal details.
- 7) Should accept all assignments in the region and comply with timelines & SOP.
- 8) Successful applicant need to sign an agreement for 6 months, renewable.

Interested agencies and/or individuals may apply only if they are qualified as per the condition of the Wealth Tax Act and ICAI guidelines 2018 and are registered with IBBI.

For immovable, Rs. 1250 + GST per Rs.10,00,000 valuation.
