1. Kalburgi Division: Bidar, Kalburgi, Raichur, Yadgir, Koppal, Bellary & Vijaynagar District.  
- 1 Valuer for immovables & 1 for Movables.
2. Belagavi Division: Belagavi, Dharwad, UK (Karwar), Gadag, Bagalkot, Vijaypura & Haveri District. - 1 Valuer for immovables & 1 for Movables.
3. Mysuru Division: Mysuru, Udupi, Hassan, Dakshina Kannada (Mangalore), Chikkamagalur, & Chamarajanagar District. - 1 Valuer for immovables & 1 for Movables.
4. Bangalore Division: Bangalore Urban, Bangalore Rural, Tumkur, Shivamogga, Davanagere, Kolar, Ramnagar & Chikkaballapura District. - 2 Valuers for immovables & 2 for Movables.

Terms & Conditions:

- 1) Should not be older than 65 years.
- 2) Should have requisite qualification as prescribed for specialization under the Wealth Tax Act.
- 3) Should be located in the Head Quarter of the regions i.e., Belagavi/Dharwad, Kalburgi/Bidar, Bangalore/Tumkur & Mysuru/Hassan.
- 4) Experience in concerned specialization for at least 5 years (at least 2 years for Central/State government or public sector Banks).
- 5) Affiliated to IBBI for at least 2 years. No record of suspension, no criminal cases.
- 6) Documents (to be scanned and uploaded to e-mail)
  - 1) Educational qualification (Highest).
  - 2) SSLC Marks card for Age.
  - 3) Experience with Central/State Government/Public sector Bank – work order / Satisfactory performance certificate.

- 4) Affidavit of not having any criminal case. Accepting Conditions of Valuation SOP and having no interest in land/real estate, scrap dealing/auctioning or having no relation formal/informal with any financial establishment or its office bearers who are charged with any fraud or violation.
- 5) PAN, Aadhar and personal details.
- 7) Should accept all assignments in the region and comply with timelines & SOP.
- 8) Successful applicant to sign an agreement for 6 months, renewable.

Interested agencies and/or individuals may apply only if they are qualified as per the condition of the Wealth Tax Act and ICAI guidelines 2018 and are registered with IBBI.

Valuation rates shall be paid as follows:

For Movables, 1.75% of valuation with equivalent markup on actual realization of excess.

For Two wheelers, Rs. 500 + GST.

For Four wheelers, Rs.1250 + GST.


Precious stones and valuables, 0.1% of value.
